Data Protection: The Club will use the information provided in this form, as well other information it obtains about the player (together "information") to administer his/her cricketing activity at the Club, and in any activities in which he/she participates through the Club, and to care for, and supervise, activities in which he/she is involved. In some cases this may require the club to disclose the Information to County Boards, leagues and the England and Wales Cricket Board. In the event of a medical or child safeguarding issue arising, the Club may disclose certain information to doctors or other medical specialists and/or to Police, children's social care, the courts, and/or probation officers and, potentially to legal and other advisers involved in an investigation.

NB: It is the Edenbridge Cricket Club policy that parents or guardians are responsible for transporting their own children to and from all matches and practice sessions and therefore Edenbridge Cricket Club will not be registering private vehicles for the transportation of individuals in connection with any fixtures or practice sessions arranged by Edenbridge Cricket Club. The implementation of this policy is not intended to exclude any player from participation and parents or guardians should contact their age group manager if they have any problems with the transportation of players to matches or practice sessions. However, there may be occasions when it is necessary for alternative transport arrangements to be made.

Wearing of Cricket Helmets

It is Edenbridge Cricket Club's policy to adopt the ECB safety guidelines on the wearing of Cricket Helmets by young players up to the age of 18. The guidance recommends that:

- Helmets with a faceguard or grille should be worn when batting against a hard ball in matches and practice sessions
- Young players should regard a helmet with a faceguard as a normal item of protective equipment when batting, together with pads, gloves and, for boys, an abdominal protector(box)
- Young wicket keepers should wear a helmet with a faceguard when standing up to the stumps.

We intend to strictly follow the ECB guidelines in this matter, and will not accept parents or guardians written consent not to allow their child to wear a helmet.

Junior Players playing in open age group cricket, this concerns the U13 age group in Year 8 who will be 12 years old on the 1st September of the preceding year.

It is Edenbridge Cricket Club's policy to adopt the ECB guidelines in the selection and participation of junior cricketers playing in adult matches. It is essential as parents/guardians that you understand that the step up from junior to senior cricket is a significant event. Edenbridge Cricket Club will select only those junior cricketers U13's (school Year 8) and below, who are considered exceptional talented players to participate adult matches. Approval for those players must be given by the Clubs Head Coach and Colts Chairman and the explicit written consent from the parents must be obtained prior to that player participating in adult match.
