

EDENBRIDGE CRICKET CLUB SUMMARY OF CHILD SAFEGUARDING POLICIES FOR JUNIOR PLAYERS, PARENTS/GUARDIANS

Edenbridge Cricket Club is committed to ensuring that cricket provides a safe, friendly and enjoyable experience for all children.

In signing the Junior Membership form, parents/guardians give permission for their child to participate in training sessions and play in any matches they may have been selected for. Furthermore by signing the Junior Membership form, parents/guardians show that they have read and agree to adhere to the Edenbridge CC Safeguarding policies and procedures.

Below is a summary of the Edenbridge CC Safeguarding policies and procedures. All policies can be found on the Club website and in a folder at the Clubhouse.

Procedure for Reporting Safeguarding Incidents and/or Concerns

Please refer all concerns and/or incident reports and/or queries to the Club Welfare Officer. For serious incidents please call the relevant authorities as a matter of priority (police, social services, etc). If you are uncomfortable acting as the whistle blower then the Club Welfare Officer will take the role for you but will still be required to make a report to the relevant authorities in person/on paper.

Transport

It is not the responsibility of the Coach or Team Manager to transport, or arrange to transport, children to and from the Club or match.

Photography/Video

While we appreciate that the importance of photographs and videos to help mark milestones in a child's life, Edenbridge CC wishes to ensure that the photograph/video footage used within cricket is taken appropriately. Photographs/images are not to be taken at matches or training without the prior permission of the parents/carers of the children. It is the responsibility of the photographer and manager/coach to communicate as to which (if any) children are to be excluded from any photographs.

Codes of Conduct

All players, parents, guardians, members and guests are expected at all times to adhere to and abide by the codes of conduct as set out in the relevant documentation and on the Club Notice Board.

Changing Rooms and Showering facilities

We do not have the facility for juniors, when playing in adult matches, to change and shower separately.

E-safety Policy

Edenbridge CC recognise that the use of the social networking sites such as Facebook and Twitter continues to grow rapidly and is increasingly being used as a
